Official Sweepstakes Rules and Regulations

No Purchase Necessary

No purchase or payment of any kind is necessary to enter or win the sweepstakes. A purchase will not improve your chances of winning.

Entry Period

Entries will be accepted online starting on December 12, 2022, at 2:30 PM (PST) and ending December 17, 2022 at 11:59 PM (PST). Each draw will be open for five days from the time they start accepting entries.

Eligibility

The Sweepstake is open only to those legal residents of Canada, excluding QC, who are 18 years of age or older as of the date of entry and who meet the eligibility requirements. Employees of The David Foster Foundation (the "Sponsor"), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to enter the Sweepstake. All Federal, provincial and local rules and regulations apply. Void where prohibited or restricted by law.

How to Enter

Each tagged account will provide entrant one entry. For each entry, participants will qualify for a chance to win the listed prize for themselves. Participants can enter all draws posted through December 12 – 17, 2022.

At the conclusion of the sweepstakes, [**@davidfosterfoundation**](#) account will announce and tag the winners in a new post.

To enter via Facebook:

As a registered Facebook Account holder, participants must like the [**David Foster Foundation**](#) page on Facebook and like the sweepstakes photo. One entry per participant. For each entry, participants will qualify for a chance to win the prize posted for themselves. Participants can enter all draws posted through December 12 – 17, 2022.

At the conclusion of the sweepstakes, The David Foster Foundation will announce and tag the winners on a new post.

To enter via Twitter:

As a registered Twitter Account holder, participants must follow the **David Foster Foundation** account on Twitter, like the tweet, and retweet. One entry per participant. For each entry, participants will qualify for a chance to win the prize posted for themselves. Participants can enter all draws posted through December 12 – 17, 2022.

The David Foster Foundation (the "Sponsor") reserves the right to delete any comments, for any reason. Winner Selection

One (1) winner will be selected by random in each six (6) draws. Winners will be chosen from all eligible entries received, and the potential winners will be notified on Instagram, Facebook or Twitter from December 19 - 24, 2022.

Potential winners will be notified by Instagram, Facebook, Twitter Direct Message and will be tagged in a winner announcing post. The winner will be required to correctly answer an unaided, time-limited, mathematical skill-testing question. Potential winners are responsible for checking their inbox for messages from The David Foster Foundation.

The potential winners will be required to respond to the notification within one (1) day.
